

# Signal Sign Systems LTD Website - Terms of Use and Privacy Policy

#### Introduction

- Use of this Internet site (the "Website") of Signal Sign Systems LTD.
   (the "Company") is subject to the terms of use and the privacy policy as detailed below.
- These terms and conditions of use (the "Terms of Use") are an integral part of the Website's regulations.
- If you access the Website and/or make use of it and its contents then
  this means that you have read and understood these terms of use
  these Terms of Use and that you have accepted, agreed and
  approved their provisions. If you do not agree, then do not use this
  website.
- All terms in the singular shall include the plural and vice versa, unless this contradicts the written subject or its content, or the context requires a different interpretation.
- Any changes made to the Terms of Use will be published on this page.
- Please feel free to contact us if you have a question or problem or if you want to report a violation of privacy.

## **Data Collection**

The data on the Website is provided by you directly and voluntarily and includes information that can reasonably be used to identify you, including your first and last name, residential address and/or e-mail, your phone number, and more ("Personal Information").

## The Reasons for Data Collection

 We use Personal Information to provide you with information that you request, among other things and as stated below in order to check your suitability for the jobs posted on the Website and for any other purpose specified in these Terms of Use, as they will be updated from time to time.

## Storage and Use of data

• We retain Personal Information as required to provide you with services, and sometimes for an additional period of time as required by law.

The Company will use the Personal Information only in a way that is in line with the objectives for which it was collected and in accordance with the Terms of Use.



- Any information or content that you publish on the Website in any way (that is not Personal Information), will not be considered proprietary or confidential and anyone exposed to them, including the Company, will be allowed to make any use of them. It is clarified that the Company and anyone on its behalf will not have any responsibility in connection with such information or content.
- Personal Information provided by you through the Website or through other means (such as e-mail, social networks and/or in any other way) for any other commercial or business purpose will be stored in the Company's database, and the Company will be entitled to use this information for the following purposes: (1) use for its own administrative, business and commercial purposes, including to contact you, by post, telephone, or e- mail; (2) making information of the candidate available to related companies and/or third parties for the purpose of carrying out the above;
  - (3) for any other commercial purpose related to the circumstances and manner by which you provided the information.
- Personal Information provided by you through the Website or by other means (such as e-mail, social networks or under the 'friend referral' model) as part of the submission of an application to fill possible positions ("Candidate Information"), is required in order to examine your suitability for the requested positions. The service rendered to you will be based on the information you provided, which will be stored in the Company's database in accordance with the requirements of law, the Company's procedures and the Terms of Use. The Company will be entitled to transfer such information to third parties at your request and at its discretion, for your benefit and/or for its own benefit, and will be entitled to use the Candidate Information: (1) for its administrative, business and commercial needs, including for establishing contact with you and for sending job offers by post, telephone or e-mail and/or social networks; (2) making Candidate Information available to related companies and/or third parties in order to receive offers for jobs/products/services that the Company believes you may be interested in. The Company will be entitled to keep the candidate's information even for a longer period than that required to fill the position for which the candidacy was submitted, and may send to you, on this basis, additional suitable job offers in the future. If you request that the Candidate Information not be transferred to third parties as specified above, you must request this from us by e-mail or registered mail, in accordance with the



contact details on the Website. The absence of a request will be considered as your having given your consent for the Company's use of the aforementioned Candidate Information.

## **International Transfers of Personal Information**

To the extent that we transfer Personal Information outside of Israel, it is done in compliance with the local privacy laws regarding the collection, use and storage of Personal Information. The processing of your Personal Information on websites or third party services (such as cloud service providers) is your responsibility, including the compliance of the information with the relevant legislation, even if you have asked us to upload the information for you or on your behalf.

# **Your Rights**

- The Company permits you to use the Website and the services included therein that are offered by it, for personal non-commercial use only, subject to the provisions of the Website and the Terms of Use.
- You are entitled to know if we hold Personal Information about you, you may review such Personal Information and correct inaccuracies, all subject to the law.

# **Applicability and Third Party Services**

- This Privacy Policy applies only to data collected by us for our own use.
- Where some of the services on the Website are managed by the Company's product and content suppliers, these services are provided through those suppliers and not from the Company's computers. When using these services, you may be asked to provide or have Personal Information collected about you. The use of this information is subject to the privacy policy of those providers and not to the Company's privacy policy, so it is recommended that you also review the privacy policy documents of these providers.

## **Protection of Personal Information**

The Company respects the privacy of its website users. Below is an overview of how the information you provide or that will be collected about you will be used when you use the Website.

#### Disclosure



- We will not sell, trade or give to any third party any Personal Information obtained from using the services or visiting the Website.
- Notwithstanding the above, we may transfer Personal Information to our service providers and/or customers who are sometimes outside of Israel, including to countries that do not grant the same privacy protection as that granted in Israel, and you agree to these transfers be made as required. In such a case, we will ensure that your Personal Information will be adequately protected in accordance with the law and our internal policies.
- In addition, certain exceptions may apply, among other things if the disclosure is required by law or if there is a need to protect the rights, property or safety of the Company, our customers or third parties, if the Personal Information is available to the public or if such disclosure is reasonably required.

## Security

- We apply information security systems and procedures on the Website and continue to improve them according to the availability of suitable new technology. These systems and procedures reduce the risks of unauthorized intrusion into the Company's computers, but they are not completely secure. Therefore, the Company does not guarantee that the services on the Website will be completely immune from unauthorized access to the information stored in them.
- The Website may contain links to and from third party websites. Following these links leads to third party websites operating under separate terms of use and privacy policy and the Company has no responsibility or liability for such websites, content, visual elements, data found in them or policies applicable to them.

#### Use of the Website

- The Website uses 'cookies', mainly for security purposes and for its regular and proper operation. Cookies are text files that your browser creates according to a command from the Company's computers.
- Some cookies will expire after you close your browser and others are saved on your computer's hard drive.
- Deleting cookies and blocking them will affect your use of the Website and may cause parts of it to not work.
- We may use network signals or other monitoring technologies.
- You cannot remove these monitoring technologies as they are part of web page content. However, in cases where they work with cookies, cancelling the cookies will also prevent monitoring of your user activity on the Website, that is, although the network signals will monitor your use as an anonymous visitor, your Personal Information will not be recorded.

# Targeted e-mail

- We may occasionally send you an e-mail containing information regarding employment options and opportunities in a company, and you hereby agree to receive inquiries from that company.
- You can choose to cancel receiving such commercial information at any time by contacting the contact address, but you will not be able to cancel the possibility of receiving service messages or other communications that may be required as part of the provision of our services.
